Subject: Restructuring of the posts of Heads of Department Cadre.

The restructuring of the Odisha Ministerial Services (Assistant and Section Officers) cadres in the offices of the Heads of Departments and the Odisha Heads of Department Establishment Officers Cadre was made earlier vide G.A.&P.G. Department Resolution No.2372/Gen., dated 24.01.2019 and accordingly, the detail of cadre strength of each Heads of Department cadre was indicated in G.A.&P.G. Department Resolution No.4509/Gen., dated 12.02.2019.

In the meantime, Labour & ESI Department have submitted proposal to restructure the HoD cadres Viz. the Presiding Officer, Industrial Tribunal, Bhubaneswar and the Presiding Officer, Industrial Tribunal, Rourkela functioning under their administrative control on the ground that the said cadres were not included in the common restructuring of the HoD cadres made vide G.A. & P.G. Department Resolution No.4509/Gen., dated 12.02.2019.

After careful consideration of the proposal of the Labour & ESI Department, the Government have been pleased to restructure the above HoDs as indicated at Annexure-A and to include the cadre strength of the said HoDs in the Resolution dated 12.02.2019 by way of partial modification of the Resolution dated 12.02.2019 to that extent.


